Minimum Award Rates of Pay

Operative Date: From the first full pay period to commence on or after 1 July 2022

The Fair Work Commission has announced a 4.6% increase to minimum wages following its 2022 Annual Wage Review. Employers need to ensure that all staff wages are above the minimum rates and that appropriate payments are made for allowances and loadings.
